### **FEES AND CONSULTATIONS**

# **Standard Consultation**

This is a consultation of up to 15 minutes with a health practitioner.

### **Extended Consultation**

This consultation is more complex, usually involving more than one medical issue and could last up to 30 minutes with a health practitioner.

# **Comprehensive Consultation**

This consultation involves an extensive examination and multiple management tools. Care plans may take up to 45 minutes and appointments may be planned accordingly.

# **POLICY**
